GREETINGS

Hello City of Aurora Ward 8 resident. I hope this newsletter finds you and your family in good health. Although COVID-19 still lingers, it has been so wonderful to see all the smiling faces of Aurora residents throughout our city. Also, please continue to respect each other's choice of masking or not masking.

Much has occurred in the City of Aurora since our last newsletter including a 2022 balanced budget with no tax increase. In 2020 and 2021, like many businesses, the city became very short staffed. In 2022, we have been diligently increasing our staffing to ensure all city services can adequately address the needs of our citizens.

Typically, I hold a Ward 8 Community Meeting at the Eola Center in March. Due to COVID-19 uncertainty, I decided to hold your next Community Meeting in the Fall at the Eola Center. Date and time TBA.

FIRST ANNUAL WARD 8 NEIGHBORHOOD CLEAN-OUT DAY

Per the request of many of you, I have scheduled the FIRST ever clean-out day for Ward 8 residents. It's time to clean out those junk areas of your house and garage and drop it off with me on Saturday, May 21st, in the parking lot of Our Lady of Mercy Church located at 701 S. Eola Rd. The trash compactor trucks will arrive at 8am and will finish at 11am. A list of acceptable items is on the back of this newsletter.

This clean-out day is for Ward 8 residents only. No appointment necessary.

MCCOY DRIVE UPDATES

Since I was elected, I have been working hard to facilitate traffic lights that were promised to Ward 8. I am happy to report the light at McCoy/Kautz/5th Avenue is being installed. Kautz/Montgomery is scheduled next, and I am pushing hard to get McCoy/Cheshire's installation date moved up.

The McCoy pedestrian bridge is scheduled to be replaced this summer. During a routine inspection, city officials noticed deterioration of the bridge. The bidding process determined the cost to rehab the bridge was nearly the same as the cost to replace it. The good news is a replacement bridge will allow for less down time of the bridge and conflicts on McCoy Drive. A crane will be used to remove and replace the existing bridge with a brand-new bridge.

SAFETY

As discussed in my previous newsletter, one of the most frequent concerns/complaints I receive from you is about speeding. It's important to understand this is not just a Ward 8 issue or an Aurora issue, it's a nationwide problem. There is no absolute solution to eliminate speeding. I continue to work with the Aurora Police Department to conduct targeted area speed monitoring which only works while APD is present. In an effort to slow traffic in Ward 8, I purchased a SPEED TRAILER. This trailer will consistently rotate throughout Ward 8 to remind drivers of their speed. We must all acknowledge that most of the speeding vehicles are our own. To keep our community streets safe, I challenge all of you to be the example and keep an eye on your own speedometer.

BLOCK PARTIES, HOA & PTA

Ward 8 residents, if you are looking to throw a block party this summer, the Alderman's office staff will assist you in the process. Call the Alderman's office at (630) 256-3020 about four weeks in advance of your gathering. Don't forget to invite your Alderwoman! HOA(s) and PTA(s) – I would love to periodically attend your meetings. I'm eager to hear what's going on in your neighborhood and in our schools! FIREWORKS - IF YOU LIGHT IT, WE WILL WRITE IT

The City of Aurora recently amended the city code with the goal of more effectively addressing illegal fireworks. In addition to calling 9-1-1, residents may now also submit complaints after the fact through our Customer Service Center. Reports may now also be submitted online at www.aurora-il.org through the Info Aurora portal or by calling 630-256-INFO (4636). This allows residents to submit photos or video of the infraction (if available), and submit a narrative supporting the complaint. Violations are now monitored through our Administrative Hearing process which will allow us to track locations with consistent complaints/violations.

Hearing officers have the ability to impose higher fines for repeat offenders and utilize the noise ordinance when determining fines, among other changes.

How can I report violations?

Call 9-1-1 to report

OR

Collect all pertinent information: time, date, location and any other specific information you are able to provide (photos, videos, etc.) and report to Customer Service at www.aurora-il.org or by calling 630-256-INFO (4636).

A city inspector may contact you for additional information to support the complaint.

PARKWAY TREES

Parkway tree planting in Ward 8 is ongoing. The COA does it's best to offer free trees to each Ward in the Spring and Fall, however the city's free tree allotment NEVER covers the need for trees in the 8th Ward. This shortfall leaves many residents in Ward 8 without a parkway tree. In 2021 Ward 8 residents requested a total of 74 parkway replacement trees. 23 of those trees were denied based on COA criteria. Nine of the parkway trees were planted by the COA's free tree replacement program. That leaves 42 residents without a parkway tree. Because I see trees as being an important factor to the beautification of our community and the good of our environment, I purchased 20 trees out of the Ward 8 budget. In the end, there were 22 residents left without a parkway tree. If you are one of these 22, it's important to understand the list does not carry over. You do need to contact customer service at 630-256-4636 and get back on the list. HOA Presidents are discouraged in pressuring homeowners to request parkway trees. It's been proven those who do not want them do not care for them. If you have any further questions about parkway trees, please contact me.

Ward 8 Grant

The Ward Committee comprised of 8th Ward residents and their Alderwoman, shall receive, review and approve requests for grants for community enhancements and/or improvements in the 8th Ward. The program, without limitations, will be geared around the following:

- Enhancements and/or improvements, such as, landscaping or infrastructure projects for public use.
- Demonstrate a benefit for the immediate area.
- Promote the character and integrity of the neighborhood and community.

The Ward Committee may also consider other information when approving or denying grant requests such as previous approvals, past history, and future development plans.

Qualifications:

Applicants must be residents of Aurora's 8th Ward or conducting business in the 8th Ward.

Applications will be accepted on a first-come, first-served basis, and funds will be distributed based on availability of annual budgeted funds at the discretion of the 8th Ward Committee and their Alderwoman. Any application(s) received after the funds are depleted, will be placed on a waiting list.
