# March 23,2010 ORDINANCE NO. <u>010</u>-09

# AN ORDINANCE AMENDING CHAPTER 48 OF THE AURORA CITY CODE IN REGARD TO A SPECIAL SANITARY SEWER POPULATION EQUIVALENT (P.E.) USE FEE APPLICABLE TO THE FOX RIVER CORRIDOR AREA OF THE CITY

BE IT ORDAINED, by City Council of the City of Aurora, DuPage, Kane, Kendall and Will Counties, Illinois, as follows:

SECTION 1: That Chapter 48, Article III, Division I of the Aurora City Code is amended by adding a new Section 48-104 thereto, which shall read in its entirety as follows:

"Section 48-104. Special Sewer P.E. Use Fee in the City's Fox River Corridor Area

- a) The City Council hereby finds as follows:
  - 1) The City of Aurora has a population of more than 25,000 persons and is, therefore, a home rule unit under Section 6(a) of Article VII of the Illinois Constitution of 1970.
  - 2) Subject to the limitations set forth in Section 6 of Article VII of the Illinois Constitution of 1970, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals and welfare.
  - 3) Pursuant to Resolution No. R06-133, approved on March 28, 2006, the City entered into an Intergovernmental Agreement ("Agreement") with the Fox Metro Water Reclamation District for the construction of improvements to the combined storm and sanitary sewer system ("Improved System") serving the Fox River corridor area ("Corridor Area") of the City which area had been served by the said combined storm and sanitary sewer system ("Combined System").
  - 4) Said Combined System was at capacity, and overflows would occur during periods of heavy rain.
  - 5) As a result of the overflows of the Combined System, new construction and redevelopment, which increase the flows into said Combined System beyond the flows occurring prior to said new construction and redevelopment, could not take place without negatively impacting the environment and the health, safety and welfare of the residents of the City, and further overburdening said Combined System.
  - 6) Said Improved System contemplated by the Agreement has been completed and has allowed and will continue to allow new construction and redevelopment to occur in the Corridor Area of the City in an environmentally safe manner.

- 7) That re-developments of existing buildings and the construction of new buildings within the Corridor Area of the City, which is graphically depicted in Exhibit A-1 attached to Ordinance No. <a href="Old-O9">Old-O9</a> and made part hereof (the "Ordinance") and legally described in Exhibit A-2 attached to the Ordinance and made part hereto, including properties adjoining or contiguous to said area which are or will be connected to the Improved System, which take place after the completion of the Improved System and the enactment of the Ordinance, will have a benefit from the Improved System, and should, as part of the sewer connection/building permit process, pay their proportionate share of the costs of said Improved System.
- 8) Pursuant to the Agreement, an additional twenty-two thousand five hundred (22,500) population equivalents (P.E.) were created within the Improved System for the benefit of the Corridor Area.
- 9) That based on the cost for the Improved System, (inclusive of debt service costs in relation thereto), the cost per newly created P.E. within the Improved System for the benefit of the Corridor Area is hereby established as Eight Hundred and Forty and no/100 Dollars (\$840.00), unless otherwise provided for in any redevelopment agreement entered into by the City prior to the effective date of the Ordinance, in which case the cost per newly created P.E. for the property covered by any such redevelopment agreement shall be as set forth in said redevelopment agreement, with Five Hundred Seventy-One and 12/100 Dollars (\$571.12) of said per P.E amount to be reimbursed to Fox Metro Water Reclamation District to cover half of the total Improved System project cost including debt service.
- b) For any redevelopment of an existing building or the construction of a new building within the Corridor Area, including properties adjoining or contiguous to said Corridor Area, or which are adjacent to a right of way that is part of the perimeter of the Corridor Area, and which are or will be connected to the Improved System, which occurs after \_\_\_\_\_\_\_\_, 2010, and requires a building permit (the "Post-System Improvement Development"), an additional fee of Eight Hundred Forty and no/100 Dollars (\$840.00) per P.E. is required (the "Fox River Corridor Area P.E. Use Fee"). The determination of the amount of said fee due and payable at the time of obtaining building permit shall be made by City staff using the pre-redevelopment/construction P.E. for the property in question and the post-redevelopment/construction P.E. for the property in question. In this regard, where a building existed on the property on March 28, 2006, but has since been demolished, the P.E. of said building, as opposed to the vacant land P.E., shall be used as the pre-redevelopment/construction P.E. for the property in question. The determination as required by this subsection shall be made in accordance with the following criteria:
  - 1) The pre-redevelopment/construction P.E. and post development/construction P.E. shall be determined by the P.E. properly documented and on file with the City from previous permit applications or by plans of the existing and proposed building(s), submitted to the City by the developer, that identify the total P.E. for the property in question pursuant to a plumbing plan of the existing and proposed plumbing fixtures and outlets and/or residential use or any combination thereof.

Any such plans or documentation shall be prepared and signed/sealed by an Illinois licensed professional engineer or architect.

2) For Residential Occupancy Uses, the pre-redevelopment/construction P.E. and the post-redevelopment/construction P.E. shall be determined using the following P.E. amounts:

3) For Non-Residential Occupancy Uses, the pre-redevelopment/construction P.E. and post-redevelopment/construction P.E. shall be determined by using the chart set forth in subsection (iii) below, based on the total number of Plumbing Outlet Units (hereinafter "POUs"). POUs for non-specific uses shall be determined based on the type and total number of plumbing fixtures as set forth in subsection (i) below. POUs for specific uses shall be based on the specific use as set forth in subsection (ii) below. The total POUs shall be the sum of the non-specific use POUs and the specific use POUs applicable to the non-residential occupancy use, rounded to the nearest whole number, with partial POUs of five-tenths (0.5) or greater being rounded up to the next highest whole number. For buildings that are divided into individual non-residential units, the total POUs shall be determined for each non-residential unit address individually and not for the building as an aggregate of the individual units.


c) After the determination as required in subsection (b) has been made by City staff, and as part of the building permit issuance process, the Fox River Corridor Area P.E. Use Fee shall be charged as part of the building permit for any Post-System Improvement Development. For buildings or portions of buildings that are divided into individual non-residential units, the Fox River Corridor Area P.E. Use Fee shall be determined for the submitted permits/plumbing plans for the building and then each non-residential build-out will be subject to the Fox River Corridor Area P.E. Use Fee associated with the proposed increase, based on the POU's proposed with the final building permit. The Fox River Corridor Area P.E. Use Fee shall be based on the following formula:

- d) The Fox River Corridor Area P.E. Use Fee shall be in addition to all other permit fees and/or connection charges for any Post-System Improvement Development. The maximum total P.E. associated with the building/property will perpetually be the sanitary load capacity associated with the site and no refund will be provided to the property owner by reduction of the P.E. thereafter.
- e) Where a redevelopment agreement entered into by the City, prior to the effective date of the Ordinance and this Section, provided for and contemplated the payment of the Fox River Corridor Area P.E. Use Fee, by the developer, at a future date, in regard to the redevelopment of existing buildings or the construction of new buildings that was to take place prior to the enactment of the Ordinance and this Section, (the "Pre-Fee Construction"), the Fox River Corridor Area P.E. Use Fee, as provided for by this Section, shall be applicable to said Pre-Fee Construction. In this regard, City staff shall calculate the applicable Fox River Corridor Area P.E. Use Fee for any such Pre-Fee Construction, and shall bill the appropriate party(ies) therefor.

**SECTION 2:** Exhibit A-1 and Exhibit A-2 attached hereto and made part hereof are the depiction of and legal description for, respectively, the Corridor Area as referenced in Section 1 of this Ordinance.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

In addition, the City agreed to execute a recapture fee to recover the improvement costs and reimburse Fox Metro.
